## 1. Introduction

---

In consideration of the Covid-19-safetyguidelines currently set in place by the Austrian government we are able to carry out our events (gatherings) in the course of the Grazer Bike-Opening in Stattegg from the 6th June 2021, with athletes and top athletes as well as supporters.

We, the Bikeclub Stattegg, are aware of our responsibility, which is why all participants are being informed about the precautions and measures in place, which we strongly advise to be followed. Above all we pander to the self-responsibility of all participants! On account of this it is forbidden to participate in the event, if any individual shows any signs of illness. In case of illness during the stay, measures will be taken immediately.

The COVID-19 concept of prevention on hand reflects the current state of science and has been developed based off of a risk analysis by the organiser in cooperation with the COVID-19 commissioner and is being put into action on site.

## 4. The event

---

### 4.1. Limit of participants

The maximal number of participants is set at 200 athletes/day plus coaches, supporters and individuals who are necessary for the execution of the event. Spectators are not allowed.

### 4.2. Registration for athletes

Online registrations are possible until 12 pm on Monday the 31st of May, 2021. Late registrations at the event are not possible.

### 4.3. Registration for supporters

Online registrations are possible until 12 pm on Monday the 31st of May, 2021. Late entries at the event are possible.

Every accredited supporter has access to the event sites.

In order to receive the accreditation and for the participation to be considered valid a valid test result has to be shown on site. According to §19 Z8, Children under the age of 10 are excluded from this obligation.

### 4.4. Accreditation

#### 4.4.1.1. Athletes and supporters

- **Every athlete and supporter** has to be present at the accreditation.
- The accreditation takes place at the Dorfplatz Stattegg/town centre Stattegg near the distribution of plate numbers. Please follow the signs.
- During the accreditation the wearing of a **FFP2 mask** is **mandatory**, as well as keeping a **minimum distance of 2 meters**.
- Temperature checks are being performed.
- To receive an accreditation a **negative test result** has to be shown.
- Every athlete has to show their **license**.
- Every accredited person receives a **ribbon**.
- **Only with this ribbon** it is possible to **collect your start number** and **enter the event site**.
- There is a separate ribbon for each event day.
- The data necessary for contact tracing is being saved and kept by the responsible data protection commissioner for 28 days, in case tracking by the authorities is required.

## 4.5. Negative Covid-19 verification

Every participating person must show proof of a **negative test result** to take part at the event. The negative test result is to be shown at registration and has to be valid until **the end of the respective event day**.

Children under the age of 10 are excluded according to §19 Z8.

Following is valid as evidence of a low epidemiological danger:

1. Proof of a negative **antigen** test result for SARS-CoV-2 from an authorised test station, which is not older than 48 hours.
2. Proof of a negative **molecular biological** test result for SARS-CoV-2 from an authorised test station, which is not older than 72 hours,
3. a medical confirmation of a past infection with SARS-CoV-2, which has been **proven molecular biologically**, over **the course of the last 6 months**,

It is possible to use the following service:

The event organisers in cooperation with the community Stattegg are offering, **tests at the town hall** during the following hours:

## 4.6. Mandatory wearing of masks

- **Compulsory wearing of FFP2-facemasks** for every participant **over the age of 14**. A face-mask of the safety category FFP2 without exhalation valve or a facemask with a normed standard equivalent or higher.
- Children under the age of 14 do not have to wear a FFP2-facemask. However, children **between the ages of six and 14 years** must still wear a mechanical safety precaution, which **fits tightly around their mouth and nose**.

## 4.7. Contact-Tracing

The personal data collected during the online registration will also be used for contact tracing if necessary. The data will be handled strictly confidential by the commissioner responsible for the protection of data and saved for 28 days in case contact tracing through the authorities is required.

## 4.8. General rules of conduct during the event

- Follow the instructions during the whole event.
- **Wearing FFP2-facemasks is compulsory** for all participants **above the age of 10**. The facemasks are only to be taken of during the competition.
- Children **between the ages of 6 and 10 must wear masks**. The facemasks are only to be taken of during competition.
- **Health check-ups** are to be performed by the participants themselves **everyday** – if any symptoms occur contact the Covid-commissioner immediately.
- Minimum distance of **2 meters** at all times.
- Cover your mouth/nose with the crook of your arm if you have to sneeze or cough.
- Wash or disinfect your hands on a regular basis.
- In case of violation of the rules of conduct the participant gets banned from the event.

## 4.9. Health check

This health check must be done IN ADVANCE of the arrival at the event as well as before the race.

Unusual aches	2 pts
Abnormal fatigue	2 pts

< or = 2	a little suspicious
3 - 5	moderately suspicious → PCR test according to the context
> or = 6	highly suspicious → PCR test

If the participant gets more than 2 points and none of the symptoms are explainable through another cause (for example allergies), he is not allowed to participate at the event. Please contact a doctor or the telephone number 1450 for health advice immediately.

## 4.10. Distribution of plate numbers

- The distribution of plate numbers takes place at **Dorfplatz Stattegg/town centre of Stattegg**.
- The pick up of the plate number is solely possible with an **accreditation and FFP2-facemask**.
- Please show your UCI-license.

## 4.11. Eventsite

### 4.11.1. Feed-/ Techzone

Entrance is only possible with an accreditation and is supervised by the responsible commissioner. The wearing of FFP2-facemasks is compulsory. Keep a distance of at least 2 meters to other supporters.

### 4.11.2. Start-/Finish area and start of the race

- Only individuals with an accreditation are permitted to enter the Start and Finish area.
- The wearing of **FFP2-facemasks** is mandatory. Competing athletes have to wear their masks up **until 3 minutes before the official start** as well as immediately after finishing the race or dropping out of the race. The masks can be taken off during competition
- During the warm up the 2-meter minimum distance is to be kept.
- The Start and Finish area must be left immediately after finishing the race.

### 4.11.3. Award ceremony

- The best three of each category are being honoured.
- FFP2-facemasks are compulsory for all attendants.
- Physical contact is prohibited (no hand shakes or hugs).

## 4.12. Other

### 4.12.1. Gastronomy

- The gastronomy area is at the event location „Lässerhof. The entry is only permitted for persons with an accreditation for the sport event of the respective day.
- Participants and staff members pick up food and drinks on their own.
- The Food is not to be consumed in proximity to the food pick up station.
- The food must be consumed seated.





#### 4.12.2. Showers

The showers at "Sporthaus Stattegg" can be used. Only a maximum of 3 persons is allowed to use the showers at once. Masks may be taken off however a minimum distance of 2 meters must still be kept.

#### 4.12.3. Camping

## 5. Occurrence of a suspected Covid-19 case

---

### 5.1. During the event

- At the occurrence of any symptoms the affected person is prohibited from attending the event.
- The affected person must contact the organiser or the Covid-19 commissioner.
- The covid-19 commissioner must contact the health hotline 1450.
- The affected person must isolate themselves in the intended room for this scenario at the community office.
- If the affected person is a minor their legal guardian has to be contacted at once.
- The Covid-19 commissioner informs the local health authorities:

- The next steps are to be determined by the local health authorities.
- Covid-19 tests and similar measures are happening on command of the local health authorities.
- The organiser supports the persecution of the measures.
- If a Covid-19 infection is confirmed the following measures are ordered by the local health authorities.

### 5.2. After the event

At the occurrence of symptoms, the affected person has to take the following steps:

- The organiser and Covid commissioner are to be contacted immediately by telephone.
- The Covid commissioner must contact the responsible authorities immediately:
